In order to process your online application, we collect and use the personal data you provide in this context (e.g. name, address, email address, education, information about technical qualifications, etc.). Insofar as your application relates to a position at another company of the Frech Group, we will forward your application there with the data you provide.
- Cookies: We do not use any cookies on our website.
